## 2018-2019 Financial Policies

### Application Fee

The application fee is non-transferable and non-refundable.

### Deposit

The deposit is non-transferable and non-refundable and is used to secure your place in school. (If you are international and your visa is denied, your deposit will be refunded.)

### Early Pay Discount

***Upon payment of deposit, the early pay discount is automatically applied to each account.*** The discount is automatically removed if tuition is not paid in full by the [Early Pay Discount Deadline](#). You can view your discount on the payments page at MyBSSM.

Please note the following policies for the early pay discount:

- The early pay discount is available for First year and Second year only.
- The early pay discount does not apply to Third year.
- To qualify, you must have paid your tuition in full by the [Early Pay Discount Deadline](#).
- Checks or cash payments must be **received before** the early pay deadline date.

### Family Discount

Family discounts apply to immediate family members attending BSSM in the same school year. For example: spouse, father, mother, child, brother, sister or grandparents. **Family Discounts are not automatically applied.** For examples of how the family discount works, please visit the finance page on [www.bssm.net](http://www.bssm.net).

Please note the following policies for the family discount to apply:

- All deposits of the immediate family must be paid prior to discount being applied
- The student is responsible to email [contact@bssm.net](mailto:contact@bssm.net) with the names of all eligible family members and a request for the family discount
- The family discount does not apply to Third year tuition, however, any immediate family member who is in First or Second year is eligible for the discount
- As an engaged couple, you will qualify for the family discount if you become married prior to registration.

### Refunds

## 2018-2019 Financial Policies

### **Domestic Registration Requirements**

In order to register, US domestic students or International students holding a Green Card must pay the deposit and first payment stated on [Page 1](#). Installment plans are only offered to students on registration day who have paid at least the deposit **and** first payment.

### **International Registration Requirements**

In order to register as an International student:

1. Tuition must be paid in full by the [International Tuition Deadline](#) (ie, have a zero balance - installment plans are unavailable for International Students).
2. Upon request, provide proof of return plane ticket home within 30 days after graduation.
3. Upon request, provide proof of sustainable living expenses for the 2018-2019 school year.
4. Without tuition paid in full and proof of all above requirements, you may be sent home on registration day.
