#### FINANCE REGISTRATION REQUIREMENTS

##### Domestic

The deposit and 1st payment must be paid by **August 15, 2019** in order to register for all 1st and 2nd year US Domestic and Green Card Holder students.

##### International

Tuition must be **paid in full** by the deadline below In order to register for 1st, 2nd and 3rd year.

## 2019-2020 Financial Policies

### Early Pay Discount - \$250

**Upon payment of deposit, the early pay discount is automatically applied to each account.** The discount is automatically removed if tuition is not paid in full by the Early Pay Discount Deadline stated on the first page. You can view your discount on the payments page at MyBSSM.

Please note the following policies for the early pay discount:

- The early pay discount is available for 1st year and 2nd year only.
- To qualify, you must have paid your tuition in full by the Early Pay Discount Deadline, July 31, 2019.
- Checks or cash payments must be **received before** the Early Pay Discount Deadline.

### Family Discount - \$1,000

Family discounts apply to immediate family members attending BSSM in the same school year. For example: spouse, father, mother, child, brother, sister or grandparents. **Family Discounts are not automatically applied.** For examples of how the family discount works, please visit the finance page on [www.bssm.net](http://www.bssm.net).

Please note the following policies for the family discount to apply:

- All deposits of the immediate family must be paid prior to discount being applied
- The family discount does not apply to 3rd year tuition, however, any immediate family member who is in 1st or 2nd year is eligible for the discount
- As an engaged couple, you will qualify for the family discount if you become married prior to registration.

To apply for the family discount, one student from the family is responsible to email [contact@bssm.net](mailto:contact@bssm.net) with the names, student ID numbers, and relationship of all eligible family members.

### Refunds

Students withdrawn from school early, before March 1, **may** qualify for a refund. Students "dismissed" from school **do not** qualify for a refund. Please email the finance department for details: [contact@bssm.net](mailto:contact@bssm.net)

### Installment Plans (Domestic Students Only)

Installment plans are only offered to 1st and 2nd year students on registration day who have paid at least the deposit **and** first payment.
